

Terms and Conditions

1. Introduction

1.1 The terms and conditions detailed in this document govern the access and use of the bridgend.ac.uk website. The Bridgend College website will be referred to in this document as the 'Site'.

2. Website Operator

The Site is operated by Bridgend College, which will be referred to in this document as 'BC', and which is based at Cowbridge Road, Bridgend.

3. Licence

3.1 BC gives you permission to use the Site on the terms and conditions detailed in this document.
